

OFFICIAL RULES

Soho Teen “Relic Revealed” Sweepstakes
No purchase necessary. Must be 13 years of age or older.

ELIGIBILITY: The Soho Teen “Relic Revealed” Sweepstakes (the “Sweepstakes”) begins at approximately 12:00 AM Eastern Time (“EST”) on July 23rd, 2013 and ends at 12:00:00 PM EST on November 5th, 2013 (the “Sweepstakes Period”). The Sweepstakes is open to legal US residents 13 years of age or older at the time of entry. Employees of Soho Press, Inc. (“Sponsor”), Sponsor’s advertising/promotions/distribution agencies, participating bookstores and libraries, and their respective parent, subsidiary, and affiliated companies, and the immediate family members (children, spouse, parents, siblings) and individuals of the foregoing residing in the same household, whether or not related, are not eligible to participate.

Only official submissions are eligible and must contain, (i) your personal information (name, street address (no PO boxes are acceptable), city, state, zip code, phone number, email address, and date of birth).
